And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 291st meeting held on 26th–27th April, 2018 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.EI.Ed. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, (NCTE) hereby grants recognition to Columbia College, Khasra No. 314/7/12/13/14/15/16/17/18, Plot No. – PH. No. – 97, Village – Tekari, Mandhar, Raipur, Chhattisgarh-493111, for an additional unit (50 students) of exisiting D.El.Ed. Programme, of 2 (Two) years duration, thus making the total annual intake to 50 students (one unit of 50 students) from the academic session 2019-2020.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

The institution shall fill the GIS information on the NCTE website within one month from the date of this order.
